- ◆ To comply with instructions issued by the Canadian Kennel Club we will be unable to accept, Alter, cancel, or substitute an entry reaching our Show Secretary after the closing date.
- ◆ It is **YOUR RESPONSIBILITY TO VERIFY** the receipt of any electronic entries prior to the advertised closing date. A valid means of payment must accompany all entries.
- ◆ All exhibitors should review Section 4.1 – Judges – General, sub sections 4.1.3,4.1.4 & 4.1.5 of the CKC Conformation Rules & Regulations
- Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made. **Refunds will not be given for anyone double entering the same dog.**
- ◆ It is the **exhibitor's responsibility** to have the dog in the ring when the dog's class is called to be judged.
- ◆ Borzoi Canada its officers & associates will use due care & diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or misfortune, to either dogs, exhibitors, or patrons. If because of riots, civil disturbances, or other acts beyond the control of the management, and it is impossible to open or complete the show, no refund of entry fees will be made
- ◆ **The Show Superintendent** will be in complete charge of the show and/or trial, which will be governed by the rules of the Canadian Kennel Club (CKC).
- ◆ **SHOW PRECINCTS** All areas set out for rings, all shelters, buildings, or facilities set out for show officials and all designated grooming areas .

COLMAR Show Service will only collect and utilize data and information that you provide us, and only for the purposes of the service we provide, exhibitors entering a CKC (Canadian Kennel Club) event, and the subsequent documents generated for this event, and required by the CKC. The type and accuracy of the information is solely contingent upon what you voluntarily provide us with. We will not use or disclose personal information for the purposes other than those for which it was collected, except with consent or as required by law. Personal information will not be retained longer than needed for the specified purposes.

### Moving a Class Dog to Specials

**Chapter 8, Section 8.9.1,** A dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to "Specials Only", providing the transfer is submitted to the Show Secretary in WRITING by the owner or handler at least one (1) hour prior to the opening of the show.

**Section 8.9.3,** When one or more all-breed and/or specialty shows are held on the same day, in the same venue, the request for moving of class dogs to specials must be made prior to the scheduled opening of the first show.

Every day of a 2 or more day show is a separate show. Please note that this rule is effective up to one (1) hour prior to the opening of the show. NOT one hour prior to the judging of the breed.

**Rules Governing This Show**

1. The Clubs reserve the right to remove any person from the show. The Show Superintendent shall have full control of the show, which will be governed by CKC rules.
2. Any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to indignities of any kind during the process of the show, and it shall be the obligation of the Club holding the show to see that this rule is effectively carried out.
3. A judge officiating at a Show held under CKC Rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the Club holding the Show to see that this rule is effectively carried out. The Show Superintendent shall promptly investigate and immediately report to the CKC any infringement of this Rule, and the Discipline Committee shall have the power to take such action as it deems fit on report indicating that this Rule has been violated (DSR Ch. 8, Sec. 14.)
4. No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of a public enemy, strikes or any other causes beyond the control of the Club.
5. The Show Committee will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, loss, or other misfortune to either dogs, exhibitors or patrons.
6. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show.
7. The owner of a dog entered in these Shows is entirely responsible for any error in entering his dog, regardless of how or by whom the entry was made.
8. Dogs must be on the grounds one hour prior to the judging of their breeds and may be removed when not required for further judging. Exhibitors are reminded that they must have their dogs at ringside when needed for judging. There will be no paging of individual dogs. No ring will be held up waiting for exhibitors or handlers.
9. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds. All dogs must be kept on leash.
10. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog before taking it to the Judging ring. Dogs are to be exercised in designated areas only, and not in the vicinity of the rings.
11. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
12. A dog once disqualified for any reason at a Championship Show held under CKC Rules cannot again be shown at a Show held under CKC rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for Reinstatement must be accompanied by a fee of \$25.00 which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned by a dog shown in violation of this Rule shall be cancelled by the CKC, and the owner of the dog is subject to disciplinary action.

**It is the responsibility of the exhibitors to be familiar with the rules pertaining to the event in which they are competing. "Dog Show Rules" are available for \$3.00 plus GST from the CKC.**

**Championship Points and Cancellations**

**Section 15.1.1** A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

**Section 15.1.2** The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs competing*:	1	2	3-5	6-9	10-12	13 or more
Points allocated:	0	1	2	3	4	5

\*includes the dog awarded WINNERS

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall be included in the calculation for championship points.

**Section 15.1.3** If a Dog awarded Winners was also awarded Best of Breed then at the show all dogs competing in the breed, including Specials Only, shall be included the total.

**Section 15.1.4** If a Dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.

**Section 15.1.5** If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

**Section 15.1.6** If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

**Section 15.1.7** The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

**Clarification:** Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

**Section 15.1.8** In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.

**Section 15.1.9** A dog may not be credited with more than 5 championship points in a single show:

**Section 15.1.10** A breed or class shall not be allowed more than 2 sets of championship points per sex on any day in the same venue.

**Section 15.1.11** A dog awarded Winners which also places Best in Show at an all-breed conformation show shall be credited with 5 championship points inclusive of any points earned at the breed and group level.

**Section 15.1.12** In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- earn at least 10 championship points under at least 3 judges; and,
- be individually registered in the records of the CKC or have an Event Registration Number.
- have earned at least one 2 point win either at the breed or group level.
